3. Booking of stalls has to be made along with the booking form for immediate booking of your preferred Stall. All Payments to be made in favour of **“Seablue Infomedia Pvt. Ltd.”** DD/ Cheque payable at Goa.

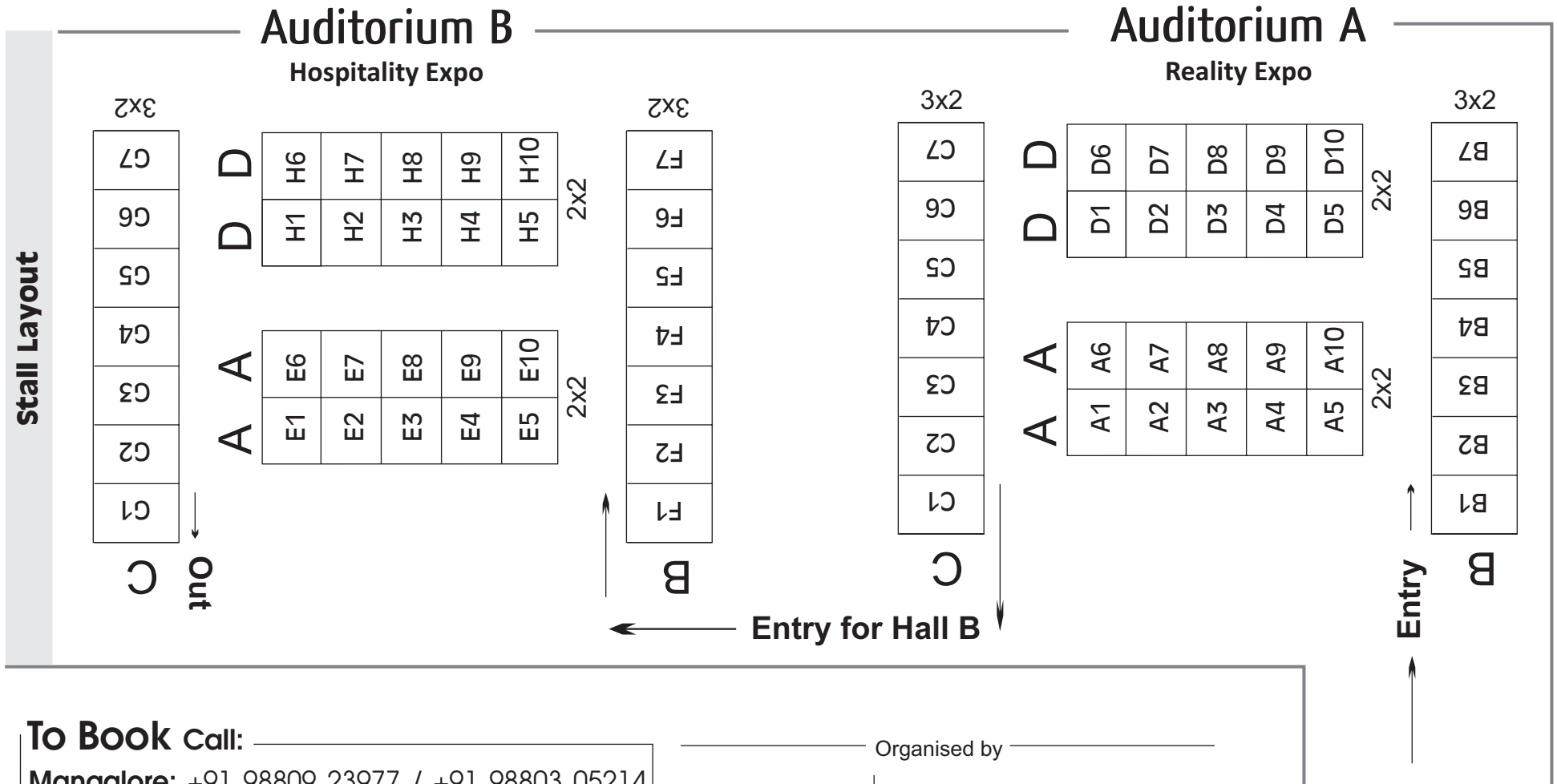
